Attributable to NHTSA:

NHTSA is currently working on a Notice of Proposed Rulemaking for regulations to meet the FAST Act requirements. We note that neither the whistleblower protection nor award provisions are contingent on a rule being in place. Whistleblowers may submit information to the Agency, and whistleblowers are afforded the protections contained in 49 USC § 30172(f). Furthermore, a whistleblower may receive an award prior to the promulgation of the regulations. We have received information and claims pursuant to the statute, which we are actively considering.
